

OWNER'S MANUAL CHINOOK RESCUE BASKET

#496

INSPECTION

Every 30 days, and after each use, carefully inspect the following:

- A. Lifting eye for damage, deformation, cracks, and corrosion.
- B. Frame assembly and bails for broken welds, bends (deformation), corrosion and abrasion.
- C. Check flotation collar and plastic net liner for cuts, tears, abrasion and any other visible damage. Repair or replace as required.
- D. Ensure flotation collar fasteners are properly secured.

Remove basket from service if inspection identifies any damage or abnormal conditions indicated above. Repair or replace basket accordingly.

MAINTENANCE

After use or as required, thoroughly wash the entire basket with fresh water and mild detergent. Rinse completely with fresh water.

REPAIR

All weld repairs shall be TIG welded by qualified welders only. **Only** minor repairs should be performed in the field.
